PRACTITIONER/SPECIALIST (GYNECOLOGIST) ON FULL TIME CONTRACT BASIS****WALK – IN – INTERVIEW**

Walk-in-interview will be held as mentioned below in Sr. DPO's office, CSMT for engagement of 02 posts of Contract Medical Practitioners (GDMO), 01 post of Contract Medical Practitioner/Specialist (**Surgeon**) & 01 post of Contract Medical Practitioner/Specialist (**Gynaecologist**), in Central Railway, Mumbai Division for a period of one year or till further orders whichever is earlier.

The engagement will be offered purely on contract basis for a period of 01 year from the date of their joining or till further orders whichever is earlier. Preference will be given to those, who can join immediately.

If the specialist of the desire branch is not responding or found unsuitable by committee, the posts will be filled by CMP/ GDMO.

Note:

- 1) Posts indicated herein may be kept unfilled at the discretion of administration.
- 2) Contract can be terminated by the Railway at any time during the contract period by giving 15 days notice without assigning any reason as per the terms and conditions laid down vide Railway Boards letter No. 96/E(GR) II/9/16 dated 23.02.2000 & No. 2008/E(GR) II/1/1 dated 16.07.2012, 28.03.2020 and 31.03.2020.

- 3) CMP's doctors, who enter into contract with the Railways will not have any claim or right for his/her continuity in service or automatic extension of the term of contract. Services rendered as fulltime contract Doctors will not have any bearing in respect of considering of their period in regular selection through UPSC, nor will it confer them any right for regulations or absorption.
- 4) Eligible SC/ST/OBC candidates may apply along with necessary caste certificate. OBC candidates have to submit certificate in Central Government format to the effect that they do not belong to Creamy Layer, from appropriate authorities.
- 5) Shortlisted candidates will have to pass the prescribed medical examination.
- 6) Duties of engaged doctors will be allocated by CMS/ KYN.
- 7) Administration reserves the right to change the place of posting as per administrative needs. The CMP specialist doctor so selected shall also have to carry out general duties as and when required by Railway administration in addition to their speciality work.
- 8) If any candidate gives refusal to join duty or give resignation after joining the duty within 01 year, the next suitable candidate will be called for engagement for the post of CMP on contract basis.
- 9) The currency of the panel will be for 01 year from publication of panel or regular incumbent is posted whichever is earlier.
- 10) This committee will take interview on regular basis on each Wednesday w.e.f. 27.12.2023, till filling of vacancy, if needed.
- 11) If the specialist of the desire branch is not responding or found unsuitable by committee, the posts will be filled by CMP/ GDMO.

Terms and Conditions-

Engagement of doctors would be on contract basis initially for a period of one year on annual basis of upto a maximum of 12 terms as per administrative requirement on the basis of assessment of performance of CMP. However services of the doctor can be terminated even before the expiry of one year after giving 15 days' Notice on either side. Railway administration reserve the right to terminate the contract at any time by giving 15 days' notice or payment of 15 days remuneration without assigning any reason whatsoever. The service tendered as contract doctor is a stop gap arrangement and will not be taken into consideration in case of selection through UPSC. It will not confer upon the many right for regularization or permanent absorption in the Railways. The engagement is purely on contract basis for a period of one year or till the regular incumbent joins, whichever is earlier.

Terms and conditions of retired Railway Doctors and Central/State Govt. retired Doctors:- Engagement of retired Rly. Doctor's and Central/State Govt. Retd. Doctors as CMPs would be purely on contract basis initially for a period of one year on a annual basis up to maximum 05 terms as per administrative requirement. The engagement of CMP shall be for a period of one year or less from the date of entering into contract or till a regular incumbent join or attaining the age of 65 years by the retired Rly. Doctor & Central/State Govt. retired Doctor, whichever is earlier. The Retired Railway Doctor & Central/State Govt. doctor engaged as CMPs shall not have any claim or right for his/her continuity in service or automatic extension of the terms of contract during the validity of contract the CMP shall be at liberty to terminate the contract for betterment of his/her career, or any ground by giving 15 days' Notice to the Railway. Rly. Administration reserve the right to terminate contract at any time during the contract by giving 15 day's Notice or Payment of 15 days remuneration without assigning any reason whatsoever.

(B) Age

For open market CMP	Not exceeding 53 years as on DATE OF NOTIFICATION relaxation for SC/ST/Ex Servicemen 5 years and OBC 3 years.
For Retired Railway/Govt Doctors	Below 65 years of age as on date of Notification.

(C) Educational/Professional qualifications:

1. For CMP/GDMO, qualification will be Degree in Medicine i.e. MBBS (recognized by the Medical Council of India, included in the first or second schedule or part eleven, of the third schedule (other than the Licentiate qualifications to the Indian Medical Council Act, 1956). Holders of educational qualifications in part II of the third schedule should also fulfil the condition stipulated in Section 13 (3) of the Indian Medical Council Act, 1956.
2. For Surgeon Specialist, qualification will be MS Surgery from recognised Indian University/MCI recognised and well acquainted with laparoscopic surgeries.
3. For Gynaecologist Specialist, qualification will be MD Gynaec & Obstetrics from recognised Indian University/MCI recognised and well acquainted with laparoscopic surgeries.
4. Candidates should have satisfactorily completed the compulsory rotating internship.

(D) Doctors serving under State/Central Govt/ Public sector undertaking etc. may apply with NOC from the respective organization.


(E) Doctors while applying should indicate past service rendered, if any including the period of contract put in by them on all over Indian Railways.

(F) Applications in the prescribed format (please refer to www.cr.indianrailways.gov.in) along with original and attested copies of certificates/testimonials should be produced, if selected at the time of joining.

(G) Original document verification of only selected candidates will be done at the time of joining and in case of any discrepancies; the next candidate from the wait list will be called for joining.

(H) No accommodation/Pass/PTO will be provided.
