7. Applications received through proper channel and with verification of service particulars, SPE/D&AR/VIGILANCE clearance and enclosure of APARs will be preferred. However a copy of application may also be sent by the applicant in advance to RLDA for timely processing of selection. On selection, the applicants will be allowed to join RLDA after NOC, vigilance/ D&AR clearance, and relieving by parent office.
